Those participating in the Dallin Museum's Art on the Green will be able to access the Green from the Municipal Parking lot behind the museum. Parking will be free on Town Day.

EQUIPMENT: Participants must supply all materials. Booth tables, tents, and chairs are the responsibility of the applicant. Each space is 10 x 10 feet.

CLEAN-UP: All participants are responsible for their space area clean-up at closing.
